



## AGREEMENT AND RELEASE FROM LIABILITY

### (Voluntary Participation)

- 3.02 This release is intended to cover any and all types of liabilities, losses, damages, costs, and expenses, which may incur from any personal injuries or property damage resulting from said horse activities.

### (Terms)

- 4.01 All persons riding under the direction of McMullen Stables agree to wear proper riding apparel including but not limited to : Protective head gear, appropriate riding boots with a heel, and riding breeches or jeans.

4.02 Parents and/or legal guardians of minors agree not to leave child unattended until instructor arrives.
